### 2.1 Students' performance in relation to those at a similar stage on comparable courses in other institutions, where this is known to you

Overall the students were of a very high standard and at a level or above those on other MSc courses known to the examiners. Written research projects were in general strong and of a high standard, with a good topic choice with no borderline candidates and some of a very high standard indeed and suitable for scientific publication. The students were highly motivated and innovative, and achieved a great deal in the short time allocated to these projects. As commented last year a few projects still relied on analysis of retrospective data sets of relatively poor or highly variable quality which limited the scope and degree of student involvement possible - it is recommended that these type of projects are discouraged in future as they are in general unrewarding and frustrating and contribute little to the knowledge base.

The Course Directors advise students to find projects that do not rely on retrospective datasets. ### 4.1 In your view, are the processes for assessment and the determination of awards sound and fairly conducted?

All processes for assessment and award determination are conducted fairly. The Course Co-ordinator communicated efficiently and the external examiners felt included in the assessment process. The research project supervisor assessment forms are valuable to the external examiners and in general were completed well although some simply ticked the boxes and did not add any comments. Supervisors should be reminded again that this is one of their responsibilities and how much appreciated it is appreciated by external examiners.

The conduct of the Board of Examiners meeting is very fair and comments of internal and external examiners are fully considered in making decisions.
