9.	<p>Requirements to Proceed (BSc Transfer)</p> <p>To Proceed to Year 4 of the BSc Veterinary Nursing To have achieved an aggregate average of at least 50% from the 3 Transfer assessments (section 5.4).</p> <p>AND To have met the requirements to be awarded the FdSc as described in section 8.</p> <p>OR To have gained a merit overall in the FdSc award</p>						
10.	<p>Consequences of Failure, Failure to Complete</p> <p>10.1. A student is required to resit any module (leading to the Foundation degree), failed at the first attempt. In order to resit a student will retake any assessment activity failed at the first attempt.</p> <p>10.2. The module marks obtained from 10.1 above will be uncapped.</p> <p>10.3. A student who fails to satisfy the requirements for the award of the FdSc VN (section 8.1) after two attempts is required to relinquish the course. They have a right of appeal as described in the College Regulations</p> <p>10.4. A student who successfully completed Year 1 remains eligible for the award of Certificate in Higher Education in Small Animal Welfare & Care.</p>

13.	<p>Absence from Summative Assessment</p> <p>Where a student has an <i>allowable</i> absence, they will be marked absent (A) from a summative assessment and will be required to sit the assessment activity at the next available opportunity.</p> <p>An allowable absence is one that is for a significant unforeseeable event such as illness. Any other foreseeable absence will only be considered allowable if agreed by the Student Performance and Development System and this will only apply in very strictly limited circumstances.</p> <p>A student absent for any other reason will be awarded 0 (zero) for the assessment.</p>
